Sealed bids shall be opened in the presence of Bidders' representatives who choose to attend at 1:00 P.M. 2081/01/12 B.S (24/04/2024 A.D.) at the office of Myanglung Municipality, Myanglung, Terhathum. Sealed Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of Rs. 50,000.00, which shall be valid for 30 days beyond the validity period of the bid i.e. 75 days.
