5. Electronic bids must be submitted to the Myanglung Municipality, Myanglung Terhathum by hand/courier or through PPMO website [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before 11:00 hrs on 2080/12/09 B.S.(22/03/2024 A.D.). Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 1:00 P.M. 2080/12/09 B.S (22/03/2024 A.D.) at the office of Myanglung Municipality, Myanglung, Terhathum. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of Rs.365000.00, which shall be valid for 30 days beyond the validity period of the bid.
